Reports

President's Report

- ID scanners are supposed to be placed at the front offices of all schools by the district but they have not been working well at their test sites. There have been lots of questions by parents, such as will the scanner do a credit check. The answer is no, but it will do a search of registered sex offenders data bases and the DMV database. Also, some parents whose legal residency statuses may be in question have mentioned that it would prevent them from coming into the schools because they would not want to show an ID, or may not have an ID to show. The school board has not sided one way or another on that issue. There have been meetings with teachers to try to address issues like these. It's not a Discovery problem yet because it has not yet been officially rolled out, don't see it happening by the end of this school year. It is currently in place at Alvin Dunn, and has worked great for the first week.
- PAC Update- School board is trying to get funds for an official Music and Arts curriculum. Luminary Arts (LA) has been successful at Richland Elementary and is being recruited district wide. Created by a teacher at Richland, runs in eight- week segments, each with a focus on a different branch of the arts. Ideally, it will be funded by grants to the district. If not, PTO's will be asked to pay for it. Per Carrie, it is very expensive. Reviews have been mixed. Cost is significantly more than our music teacher's current salary. We would still be able to keep our music teacher and she would be given the option to become an employee of LA. This is all in the works, not yet clarified.

- 700 yearbooks ordered for sale, of which 360 have already been sold. Typically, 45% of the yearbooks are sold the last few days of the school year.
